AMENDED CERTIFICATION OF REPRESENTATIVE

The Certificate of Representative (PERB Certification No. 19) issued in this matter on May 4, 1983, is hereby amended to include the following Authorization for an appropriate unit to collectively bargain over compensation with the District of Columbia Public Schools:


AUTHORIZATION

Pursuant to §502 (a) and 1716 (b) of the District of Columbia Comprehensive Merit Personnel Act of 1978, (D.C. Code §1-605.2 and §1-618.16) the Public Employee Relations Board (PERB or Board) determines that the unit certified for non-compensation bargaining in the attached "Certification of Representative" is appropriately included in the following unit for the purpose of compensation bargaining for fiscal years following 1983:

UNIT 17 - Consisting of all personnel who render educational, technical and administrative support services, who have their compensation set in accordance with Educational Grade (EG) classifications 11 and 12, who come within the personnel authority of the District of Columbia Board of Education and who are currently represented by a labor organization certified as an exclusive bargaining agent for non-compensation by the PERB or its predecessor.

IT IS HEREBY CERTIFIED THAT:


