

SUBJECT: Certification Exclusive Representative

I recommend that Laborers' District Council of Washington, D. C. and vicinity, Local 571, affiliated with Laborers' International Union of North America, AFL-CIO be certified as exclusive representative for a unit of:

All non-professional employees of the Office of the Chief Medical Examiner, Department of Human Resources, excluding management executives, confidential employees, supervisors, or any employee engaged in personnel work in other than a purely clerical capacity.

Enclosed is an October 9, 1975 memorandum (petition) from the D. C. Director of Personnel and a letter of September 3, 1975 from the union. These documents are self explanatory. They indicate that the Union has a unit membership consisting of all twelve (12) employees in the proposed unit, that there is no dispute as to the appropriate unit and no rival organization.

This matter will be on the agenda for November 17.
