AUTHORIZATION

Pursuant to Sections 502(a) and 1716(b) of the District of Columbia Merit Personnel Act of 1978, (D.C. Code Sections 1-605.2 and 1-618.16) the Public Employee Relations Board (PERB or Board) determines that the unit found appropriate for non-compensation bargaining as described in the "Certification of Representative" in PERB Case No. 93-R-02 shall be included in the following unit for the purpose of compensation bargaining:

UNIT 1 - consisting of all career service professional, technical, administrative and clerical employees who currently have their compensation set in accordance with the District Service (D.S.) Schedule and who come within the personnel authority of the Mayor of the District of Columbia, the Board of Trustees of the University of the District of Columbia and District of Columbia Board of Library Trustees, except physicians employed by the Department of Human Services and Department of Corrections and registered nurses employed by the Department of Human Services.

CERTIFICATION OF ELECTION RESULTS

The results of a secret ballot election in the above-captioned proceeding have been duly reported to the parties on June 25, 1993, as follows:

"Pursuant to the Decision and Order of the Public Employee Relations Board (Board) issued on May 10, 1993, (Opinion No. 354) an on site secret ballot election was conducted on June 22, 1993, in the above-captioned proceeding, with the tally taking place at Department of Public Works, Water and Sewer Utility Administration, 3rd Floor Conference Room, 5000 Overlook Avenue S.W., Washington, D.C.

The Election was conducted by the staff of the Board in accordance with the election Procedures of the Board's Rules and an election agreement duly executed by the parties to this proceeding. The secrecy of the ballots was maintained at all times. A total of twenty-three (23) ballots were received on the question only for professional employees. A total of eighty-three (83) ballots were received on the question for professional and non-professional employees.

In accordance with the above-referenced Election Agreement, the question on the ballot for professional employees was, "Do you desire inclusion in a consolidated unit of professional and non-professional employees of the D.C. Department of Public Works for purposes of collective bargaining on compensation and terms and conditions of employment by the American Federation of Government Employees, Local 631, AFL-CIO (AFGE)? The question on the ballot for professional and non-professional employees was, "Do you desire to be represented, for purposes of collective bargaining on compensation and terms and condition of employment by the American Federation of Government Employees, Local 631, AFL-CIO (AFGE)?"
