DECISION AND ORDER

A standards of conduct complaint was filed with the Public Employee Relations Board ("Board") naming Paul Sinclair and Tameika Massey as complainants and Yvonne Robertson Smith as respondent. The parties were alleged to be officers of the Fraternal Order of Police/District of Columbia Housing Authority Labor Committee. Paul Sinclair ("Complainant") signed the complaint; Tameika Massey did not sign the complaint.

On April 12, 2010, the Executive Director sent Complainant a letter notifying him that in violation of Board Rules the complaint omitted a caption and a clear and concise statement of the facts constituting the alleged violation. *See* Rules 501.7, 501.8, and 544.3(c). In accordance with Rule 501.13, the notice allowed Complainant ten (10) days from the date of the letter to cure the filing deficiencies.

Rule 501.13 provides, "Failure to cure deficiencies shall result in dismissal without further notice." More than the ten days prescribed by the notice and Rule 501.13 have passed, and as of October 18, 2012, the Complainant has not cured the deficiencies. Therefore, pursuant to Rule 501.13 the complaint is dismissed with prejudice.

ORDER

IT IS HEREBY ORDERED THAT:

1. The standards of conduct complaint is dismissed with prejudice.
