1. The Complainants' Motion for Preliminary Relief is denied.
2. Since PERB Case Nos. 10-S-05 and 10-S-07 involve common issues, we are consolidating these cases
3. The Board's Executive Director shall refer the consolidated standards of conduct complaint to a Hearing Examiner and schedule a hearing under the expedited schedule set forth below.
4. A hearing shall be scheduled in the consolidated cases before June 30, 2010. The notice of Hearing shall be issued seven (7) days prior to the date of the hearing.
5. Following the hearing, the designated Hearing Examiner shall submit a Report and Recommendation to the Board no later than twenty-one (21) days following the conclusion of closing arguments or the submission of post-hearing briefs.
6. Parties may file exceptions and briefs in support of the exceptions no later than seven (7) days after service of the Hearing Examiner's Report and Recommendation. A response or opposition to the exceptions may be filed no later than five (5) days after service of the exceptions.
7. Pursuant to Board Rule 559.1, this Order is final upon issuance.


