<u>ORDER</u>

The Public Employee Relations Board (Board) having considered the parties' submissions concerning the Board supervised general election which was conducted by the League of Women Voters in the above-captioned case, hereby adopts the following order.

IT IS HEREBY ORDERED THAT:

1. The Motion To Intervene filed on behalf of interveners Mack, Butler, Lee and Simmons is granted.

2. The results of the April 30, 1996 mail ballot general election for the positions of vice-chairperson, treasurer, secretary, and recording secretary are hereby certified.

3. The result of the April 30, 1996 mail ballot general election for the position of chairperson is hereby held in abeyance pending the outcome of the Board's decision in the matter of <u>Clarence Mack v. FOP/DOC Labor Committee</u>, PERB Case No. 95-S-03. If Mr. Mack prevails in PERB Case No. 95-S-03 and his expulsion from union membership is rescinded, he will be eligible to hold office and the election result for the position of chairperson will be certified. However, if the FOP/DOC Labor

Committee's expulsion of Mr. Mack is found not to have violated the standard of conduct for labor organizations under D.C. Code, section 1-618.3, the election results with respect to chairperson will be set aside and a special rerun election for chairperson shall be conducted under the supervision of the Board and administered by a neutral third party designated by the Board with the expenses of such election to be borne solely by the FOP/DOC Labor Committee (FOP).

4. Pending the outcome of PERB Case 95-S-03, Mr. Mack is not eligible to hold any office.

5. Consistent with paragraph 3 of this Order, the position of chairperson will be treated as vacant until Mr. Mack's eligibility is determined in PERB Case No. 95-S-03. While the position of chairperson remains vacant, the vice-chairperson shall perform the duties of chairperson as required by article 6.2 of the FOP/DOC Labor Committee by-laws.

6. The Respondent shall forthwith (not later than 3 days) from the service of this Order, post a Notice to FOP members stating that the Board has certified the results of the election for the position of vice-chairperson, treasurer, secretary and recording secretary. Also, the Notice shall state that the results of the election for the position of chairperson shall be held in abeyance pending the Board's decision in PERB Case No. 95-S-03. In the meantime, the vice-chairperson shall serve as chairperson.

7. The Notice to members mentioned in paragraph 6 of this Order shall be conspicuously displayed on all bulletin boards where notices to members are customarily posted for thirty (30) consecutive days.

8. The Respondent shall notify the Board, in writing, within fourteen (14) days from the issuance of this Order, that the Notice to Members has been posted accordingly.
