- 1. The Complainants' Motion for Preliminary Relief is denied.
- 2. Since PERB Case Nos. 10-S-05 and 10-S-07 involve common issues, we are consolidating these two cases.
- 3. The Board's Executive Director shall refer the consolidated standards of conduct complaint to a Hearing Examiner and schedule a hearing under the expedited schedule set forth below.
- 4. A hearing shall be scheduled in the consolidated cases before June 30, 2010. The notice of Hearing shall be issued seven (7) days prior to the date of the hearing.
