ORDER

On April 21, 1992, the Public Employee Relations Board (Board) issued Opinion No. 307 in this proceeding directing the above-captioned parties to submit to the Board, within 14 days from the issuance of that Order, their final recommendations for achieving the remedial objectives of the Board's Order in Opinion No. 285. On May 5, 1992, the parties jointly submitted a document entitled "Interim Report of the Parties Pursuant to the Order in PERB Opinion No. 307."

At the conclusion of the Report, the parties requested that the Board grant them leave until June 15, 1992, to continue their efforts to fashion a mutually acceptable remedy that is consistent with the objective of paragraph 5 of our Order in Opinion No. 285.

The Board hereby grants the parties' request for leave until June 15, 1992, to comply with paragraph 6 of the Board's Decision and Order in Opinion No. 285. We are dismayed at the length of time it has taken for the parties to comply with our directives and strongly urge the parties to hasten the conclusion of this process. If an agreement has not been reached by June 15, 1992, each party shall (without further delay) provide the Board with a final report which will include their respective recommendations toward achieving the objectives of paragraph 5 of the Order in Opinion No. 285. Following the consideration of the parties' report(s), the Board shall issue a Supplemental Order establishing the final remedy in accordance with the remedial objectives set forth in our Order in Opinion No. 285.
