In view of the time sensitive posture of this case, the Board has decided to issue its Order now. A decision will follow. The Board having considered the parties' "Joint Petition for a Compensation Unit Modification," hereby determines that it is appropriate to consolidate Compensation Units 1 and 15, by merging those employees who are currently in Compensation Unit 15 into Compensation Unit 1.

IT IS HEREBY ORDERED THAT:

- 1. The parties' "Joint Petition for Compensation Unit Modification," is granted.
- 2. Compensation Units 1 and 15 are consolidated. Specifically, Compensation Unit 15 which consist of "non-faculty employees who come within the personnel authority of the Board of Trustees of the University of the District of Columbia, who are classified as educational

employees and who [are] currently ... represented by [AFSCME, Local 2087]," 1 is folded into and becomes a part of Compensation Unit No. 1. 2
